## Modification Details

Purpose: The purpose of this modification is to incorporate changes to all SeaPort-e Prime Contracts.

Modification:

1. All clauses are updated with latest revisions as of 1 July 2017.

2. In Section D, HQ D-1-0001, change the third paragraph to read:

Classified reports, data, and documentation shall be prepared for shipment in accordance with National Industrial Security Program Operating Manual (NISPOM), DOD 5220.22-M dated 28 February 2006 with Change 2 dated 18 May 2016.

3. In Section H:

a. In H.5 remove all references to Economically Disadvantaged Women-Owned Small Businesses (EDWOSB) and replace with Women-Owned Small Businesses (WOSB). This change is because EDWOSB set-aside is not applicable for NAICS 541330 but WOSB is acceptable.

b. In H.22, update the email address for the SeaPort-e helpdesk in the last sentence.

The SeaPort-e helpdesk email address is support@seaport.help if assistance is needed.

4. In Section I:

a. Clauses by reference are updated with latest revisions as of 1 July 2017.

b. Delete the following clause:

c. Add the following clauses by reference:

52.203-19 Prohibition on Requiring Certain Internal Confidentiality Agreements or Statements (JAN 2017)

52.209-11 Representation by Corporations Regarding Delinquent Tax Liability or a Felony Conviction(FEB 2016)

52.219-9 ALT II (Dev) Small Business Subcontracting Plan (Deviation 2016-O0009) JAN 2017

52.219-30 Notice of Set-Aside for Women-Owned Small Business Concerns Eligible Under the Women-Owned Small Business Program (DEC 2015)

252.239-7000 Protection Against Compromising Emanations (JUN 2004)

d. Replace the full text DEC 2014 version of FAR 52.222-55 Minimum Wages Under Executive Order 13658 with the revised DEC 2015 clause.

5. In Section J delete all references to attachments; there are no attachments to the Seaport e MAC Base Contracts.

6. In the Option to Extend Services modifications that were completed in May 2014 for the FY04, FY09, FY10, FY11, FY12 and FY14 SeaPort-e Contracts there was a typo in the Clause number referenced in Block D. Block D is corrected to read: FAR 52.217-8 Option to Extend Services (Nov 1999).

7. All other terms and conditions remain unchanged and in full force and effect.
